

CANADIAN KENNEL CLUB RECOGNIZES TWO NEW DOG **BREEDS**

The Canadian Kennel Club is excited to announce a significant update to its Articles of Incorporation – the recognition of two new distinct breeds: Parson Russell Terrier and Russell Terrier.

This amendment, certified under the Animal Pedigree Act, 1988, reflects the commitment of the CKC to celebrating the diversity and heritage of purebred dogs. Certification was finalized on June 30, 2025, and includes the official Rules of Eligibility (ROE) for breeding.

Each of these breeds brings unique qualities and histories to the CKC community, and their official recognition opens new opportunities for owners, breeders, and enthusiasts to engage with the club.

Over the coming weeks, CKC will make any necessary changes to our systems and official documents (i.e. forms, policies, ROEs, etc.) to implement the changes from the 2022 Referendum recognition of the Parson Russell Terrier and Russell Terrier. We will notify our members when these changes are complete, when you can view their Rules of Eligibility before registering new dogs and read the changes in the updated By-laws booklet and Policy & Procedure Manuals.

These breeds are now fully recognized by the CKC. Stay tuned for more updates!

CKC VETERINARIAN STUDENT BURSARY

The five veterinary colleges in Canada receive the annual CKC Veterinary Student Bursary in the amount of \$2,000 to award a deserving student to continue their education in the field of veterinary medicine and to support important veterinary programs.

Our second bursary of 2025 was presented at the Western College of Veterinary Medicine award ceremony at the University of Saskatchewan, on June 4, 2025. Valerie Bandas, CKC Zone 9 Director, Saskatchewan, attended and was honoured to present the award to Yovela Wang, MSC, DVM. Dr. Wang will be continuing her veterinary studies in oncology and is passionate about individualized care and providing compassionate support to both her patients and their families.

We are looking forward to supporting the remaining veterinary colleges this year and will provide these important updates with our members when available.

CKC NATIONAL CHAMPIONSHIP DOG SHOW RECOGNIZED AS **CRUFTS QUALIFIER!**

The Canadian Kennel Club invites its members and exhibitors to take part in the Crown Classic National Championship Dog Show weekend November 20 - 23, 2025 at the International Centre in Mississauga, Ontario, presented by Royal Canin, the Canadian Pet Expo, the Aurora and District Kennel Club, and the Canadian Kennel Club. As a feature part of the weekend's events, we hope you will join us at the 2025 CKC National Championship Show on Saturday, November 22, 2025. The CKC National Championship Show will be a 2026 Crufts Qualifier!

Effective immediately, Best of Breed winners at the 2025 CKC National Championship Show will be eligible to enter Crufts 2026. This marks an important addition to the list of qualifying achievements for Canadian dogs competing on the international stage.

The following Canadian dogs are eligible to compete at Crufts 2026:

- The top five dogs of each breed, as determined by the CKC Top Show Dog point system
- · Dogs awarded Best of Breed, Best of Opposite, Select Dog, Select Bitch, or Award of Merit at CKC-approved National Specialties
- · Best of Breed winners at the 2025 CKC National Championship Show


Please note: Qualifications are only valid for the following year's Crufts event and cannot be deferred. For example, a dog that qualifies at the CKC National Show in 2025 is eligible for entry into Crufts 2026 only.

Who We Are

The Canadian Kennel Club (CKC) is the primary registry body for purebred dogs in Canada and currently recognizes 187 breeds. As a non-profit organization, the CKC is dedicated to encouraging, guiding, and advancing the interests of purebred dogs and their responsible owners and breeders in Canada and promoting the knowledge and understanding of the benefits which dogs can bring to Canadian society.

The CKC is incorporated under Animal Pedigree Act, a federal statute under the auspices of the Ministry of Agriculture. The organization includes approximately 20,000 individual members and over 700 breed clubs across Canada. The Club registers purebred dogs, regulates dog shows and performance events, and speaks out on major issues concerning dog ownership and the health & welfare of dogs across Canada.

Mission

As the prime registry of purebred dogs in Canada, our purpose is to serve our members and the public with education, support, guidance and sanctioning of events for all their canine endeavours. Our goal is the preservation of purebred dogs and the health, well-being and enjoyment of all dogs.
