

NOTICE: BREED STANDARD UPDATES EFFECTIVE JULY 1, 2025

The CKC website now includes a new section for "Breed Standard Updates," which can be found at the bottom of the CKC Breed Standards webpage. This section will only be used for breed standard changes that have been approved by the Board.

The following breed standards have been updated by the Board effective July 1, 2025:

Group II (Hounds):

• Borzoi

Group IV (Terrier):

· American Hairless Terrier

The following breed standards have corrections:

Group III (Working):

- Bernese Mountain Dog -Section on Neck that was omitted has been added back
- Doberman Pinscher DO overshot more than 4.75 mm (0.1875 in)
- Leonberger Tips of ears are level with corners of the mouth

Group V (Toy):

• Japanese Chin - Subheading for Body added

Please note that there is no longer a Breed Standard Amendment Service. Judges and clubs will be required to update their Breed Standard binder by printing updated pages on their own. For printing, breeds can be found within their respective group's "Individual Breed Standards" folder. Electronic versions can still be downloaded as full groups.

The Disqualification Booklet will continue to be updated and mailed each year or as required. The next update will be printed and issued in July 2025.

UPDATED DISTANCE REQUIREMENTS FOR OBEDIENCE AND RALLY OBEDIENCE TRIALS

This notice is to provide you with an update regarding the distance requirement between Obedience Trials and Rally Obedience Trials.

The motion below was carried at the May/June Board Meeting and is effective immediately.

"THAT, the Policy & Procedures Manual, Chapter 6 Shows and Trials, Appendix 2 Mileage Restrictions be amended effective immediately as follows:

Shows And Trials

Appendix 2 - Mileage Restrictions

Note: Mileage Restrictions listed are for the distance required

between events of the same type. For judging restrictions, please refer to the event rule book.

- Obedience Trials (clubs without priority dates) -100 miles /180 kilometres
- · Obedience Trials (clubs with or up against a club with priority dates) - 200 miles / 322 kilometres
- Rally Trials (clubs without priority dates) -100 miles / 180 kilometres
- Rally Trials (clubs with or up against a club with priority dates) - 200 miles / 322 kilometres

This means that effective immediately, for clubs applying to hold either an Obedience Trial or Rally Obedience Trial, if there is another club holding trials on the same date and both clubs do not have priority dates, the distance between Obedience Trial to Obedience Trial and Rally Obedience Trial to Rally Obedience Trial must be a minimum of 180 kms.

For clubs applying to hold an Obedience Trial or Rally Obedience Trial that have priority dates, if there is another club holding trials on the same date that also has priority dates, the distance between Obedience Trial to Obedience Trial and Rally Obedience Trial to Rally Obedience Trial must be a minimum of 322 kms.

For a club applying to hold an Obedience Trial or Rally Obedience Trial that does not have priority dates, if there is another club with priority dates holding trials on the same date, the distance between the events must be 322 kms.

Please be reminded that this is for the same event type only.

Trials that have already been approved and for clubs that submitted an Event Date Application prior to the date of the Board Meeting, the distances for these specific events will be grandfathered. For all others, and in future, the new distance requirements will be in effect.

CKC INTRODUCES NEW ICONIC BREEDER CONFORMATION JUDGE PROGRAM

The Canadian Kennel Club is pleased to announce a new Iconic Breeder Conformation Judge program.

The program is intended to allow CKC member breeders the opportunity to obtain a judge licence for 1 breed for which they are considered "iconic" in breeding and showing.

A breed that they have been breeding for a minimum of 25 years and for which they can meet the requirements as set in policy with regard to breeding, showing, awards, champions and much more. Please review the policy in this regard in the Policy & Procedures Manual, Chapter VII, Judges, Section C, Applicant Iconic Breeder Conformation Judge Licencing Program for all of the eligibility requirements and approval process.

This is for 1 breed only and successful applicants cannot progress from this program to judge further breeds. Iconic Breeder Conformation Judges must be CKC members and must adhere to the same Code of Ethics for Judges as all other licenced judges.

The Application For Iconic Breeder Conformation Judge can be found on the website under Events> Event Forms>Judges.

This new program is effective July 1, 2025.

The fee to apply to become an Iconic Breeder Conformation Judge is \$100.00 plus tax.

PAWS AND POETRY: A CKC MEMBER'S ODE TO PUREBRED DOGS

What happens when a lifelong dog lover with a passion for writing takes on a poetic challenge like no other? Colleen Rutherford Archer has written a poem for every purebred dog breed recognized by the Canadian Kennel Club. With a career spanning short stories, novels, and factual articles, Colleen has turned her deep affection for dogs into a joyful and informative tribute to the breeds we know and cherish.

Now retired from professional writing, Colleen finally found the time to take on an idea that had lingered for decades. "Years ago, an editor suggested a book of dog poems," she recalls. "But it would have to include every recognized breed, and I didn't have time back then. Now I do, and I decided to do it just for fun."

Colleen's playful verses aren't just charming, they're packed with carefully researched details about each breed's origins, traits, and original purpose. "I spent over half a century researching articles, so diving into breed histories was a pleasure," she says. "I used everything from breed books to videos of dogs with their owners."

One of her favourite discoveries? The Norwegian Lundehund, a breed known for its flexibility, extra toes, and puffin-hunting past. "The Lundehund was definitely the most fun dog to research," she says. "The poem practically wrote itself."

He once hunted puffins among creviced rocks... His forelegs can stretch out to ninety degrees, While extra toes help him to grip rocks with ease.

Colleen's connection to dogs runs deep, especially with the breeds she has shared her life with. Her Shetland Sheepdog Vicky earned her Utility title at just two years old. Robin, her Cairn Terrier, was a therapy dog who also played Toto in a stage production of The Wizard of Oz. "I probably saw parts of them in the breeds I wrote about," she says.


Over the years, her poems have drawn praise from editors, breed lovers, and even the late Barbara Woodhouse, the British dog trainer who coined the phrase "Walkies!" "She wrote to say she really enjoyed the poems and would treasure them," Colleen says. "That meant a lot."

So why poetry? "Poems can be a bit lighter than factual articles while still conveying information," she explains. And in Colleen's hands, a few clever lines can say a great deal about a dog's temperament, its history, and why it might be a perfect match for the right home.

At the heart of it all is a deep respect for the bond between people and dogs. "Looking at what a breed was originally bred to do gives people a good hint at what that pup will grow up to be like," she says. "Starting out with the right dog is so important, and that's where the CKC can really help."
