

MARK YOUR CALENDARS FOR **VOTING! NOTICE OF 2025 CKC** REFERENDUM

The Canadian Kennel Club is YOUR club. We need you to VOTE in this year's Referendum to ensure our members' voices are heard when important decisions are being proposed.

Following the December Board of Directors' meeting, the Board has ordered a Special Referendum Ballot to take place June 1, 2025.

A copy of all Proposed Amendments, including 40 Rules of Eligibility changes as well as By-Law changes, will be shared with you in the coming months before the Referendum.

In order to be eligible to vote in a Special Referendum, a member must meet all of the following requirements at least fifteen (15) days prior to distributing the ballots:

(a) be a member in good standing

- (b) be a resident of Canada
- (c) have completed one (1) continuous year of membership in the Club
- (d) have attained the age of nineteen (19) years

We need your VOTE! In order to ensure your voice is heard and you can vote, your CKC membership must be renewed. If you haven't already done so, you can renew your membership today in your Member Portal.

We are ready to accept litter and dog registration applications for the 4 newly recognized Breeds approved as part of the 2022 Referendum. The 4 New Recognized Breeds are Azawakh, Japanese Akita, Miniature American Shepherd and the Russkiy Toy.

If you have an existing Miscellaneous Number for your Azawakh, Japanese Akita, Miniature American Shepherd or Russkiy Toy, the CKC has converted that number to a CKC registration number, and you can find that number by logging into your Member Portal.

Climbing the ladder to Westminster





THE FASCINATING HISTORY AND LEGACY OF THE GERMAN SHEPHERD DOG CLUB OF CANADA

The German Shepherd Dog (GSD) is one of the most iconic and versatile breeds in the world. Known for their intelligence, loyalty, and courage, these dogs have a storied history. Explore the early days of the Alsatian Shepherd Dog Club of Canada, the origins of the GSD, and the story behind the breed's alternate name: the Alsatian.

The Alsatian Shepherd Dog Club (ASDC) of Canada, now known as the German Shepherd Club of Canada, was established in 1922, providing a foundation for GSD enthusiasts in the country. The Club's Constitution and By-Laws were approved on September 5 of that year, and their affiliation with the Canadian Kennel Club (CKC) soon followed. By January 1923, the Club held its first Annual Meeting in Burlington, Ontario, electing officers and appointing honorary leaders, including Mr. J. Russell, the CKC President.

The German Shepherd Dog's story began in the late 19th century, when Captain Max von Stephanitz, a German cavalry officer, envisioned creating the ultimate working dog. His efforts led to the development of a breed known for its intelligence and versatility—excelling in roles such as herding, police work, search and rescue, and guiding the visually impaired. The breed gained fame in North America in the 1920s, thanks to two canine movie stars who captured the public's hearts. Strongheart, registered as Etzel von Oeringen (1917–1929), and Rin Tin, rescued from a World War I battlefield (1918-1932), became instant celebrities both onscreen and off. Their talent and charm boosted the breed's popularity worldwide, with Rin Tin Tin especially securing his place as a Hollywood icon.

During World War I, German Shepherds served heroically as messengers, ammunition carriers, and guides for wounded soldiers. However, anti-German sentiment after the war led to the breed's rebranding in the United Kingdom. To avoid associations with Germany, the name "Alsatian" was adopted, inspired by the Alsace-Lorraine region bordering France and Germany. This name allowed the breed to thrive without

controversy.

From their German beginnings to their global recognition, GSDs continue to be celebrated for their intelligence, versatility, and loyalty - qualities that have endeared them to dog lovers for generations. As we reflect on the remarkable history and enduring legacy of the German Shepherd Dog, we would like to recognize the German Shepherd Dog Club of Canada for over 100 years of dedication and excellence as part of the Canadian Kennel Club family. Since its founding in 1922, the Club has worked tirelessly to preserve and promote the breed's intelligence, versatility, and loyalty.

The Canadian Kennel Club (CKC) is the primary registry body for purebred dogs in Canada and currently recognizes 187 breeds. As a non-profit organization, the CKC is dedicated to encouraging, guiding, and advancing the interests of purebred dogs and their responsible owners and breeders in Canada and promoting the knowledge and understanding of the benefits which dogs can bring to Canadian society.

The CKC is incorporated under Animal Pedigree Act, a federal statute under the auspices of the Ministry of Agriculture. The Club registers purebred dogs, regulates dog shows and performance events, and speaks out on major issues concerning dog ownership and the health & welfare of dogs across Canada.
