## CKC RECOGNIZES FEDERACIÓN CINOLÓGICA DE CUBA (FCC) AS A FOREIGN STUD BOOK

CKC is pleased to announce that the Board of Directors has approved recognition of the Federación Cinológica de Cuba (FCC) as a Foreign Stud Book (September 6, 2025).

With this decision, the FCC has been added to CKC's List of Recognized Foreign Stud Books, CKC and FCC now mutually recognize registration certificates and pedigrees, and dogs imported into Canada that are registered with the FCC are eligible for full CKC registration.

The FCC has been an FCI member since July 27, 1987. We look forward to a formal relationship that supports dog health and wellbeing and expands opportunities for Canadian and Cuban purebred dog enthusiasts.

## NOTICE TO CONFORMATION JUDGES RE: NEW BREED 2026 (SWEDISH LAPPHUND)

Effective January 1, 2026 the Swedish Lapphund will be eligible to compete as a Listed Breed in Group 7 (Herding).

In accordance with CKC policy, CKC All Breed Judges and Breed/ Group Judges that are licensed or on permit to judge breeds in Group 7 will be required to successfully complete an Open Book Test for this new breed prior to being approved to judge it.

The Open Book Test will be available for you to complete, using our Online Learning Platform, Teachable. You can login using the credentials CKC has provided to you, along with instructions on how to navigate and use the online platform.

A picture of the breed will be available on Teachable platform.

In the meantime, if a Judging Panel is submitted to Head Office for an event after January 1st and it does not include this breed, we will communicate with the club to assign the breed to a judge on the judging panel.

Lastly, please note that in accordance with CKC policy, copy below, judges will have 6 months from this memo to complete the Open Book Tests without being assessed any fees. However, the test must be successfully passed before any assignments for all breeds in Group 7 on January 1, 2026 or later.

"When a new breed is approved by the Board, conformation judges will be provided with a 6 month period to write an Open Book Test for that breed, after which, an administrative fee as set by the Board will be implemented."

## APPEAL COMMITTEE REPORT

#### **Appellant: Inga Jansone (CKC Member)**

**Respondent: CKC** 

#### Discipline Committee's Findings:

Inga Jansone's CKC membership be terminated for a period of three (3) years. Furthermore, the Discipline Committee levied costs associated with the investigation and hearing in the amount of \$282.50 (including HST) against Inga Jansone.

#### Appeal Committee's Findings:

Upheld the appeal in whole and the decision of the Discipline Committee be set aside.

#### **Appellant: Patricia Kastanek (CKC Member)**

**Respondent: CKC** 

#### Discipline Committee's Findings:

Partricia Kastanek's CKC membership be terminated for a period of three (3) years. Furthermore, the Discipline Committee levied costs associated with the investigation and hearing in the amount of \$282.50 (including HST) against Patricia Kastanek.

#### Appeal Committee's Findings:

Upheld the appeal in whole and the decision of the Discipline Committee be set aside.

#### **Appellant: Sarah Muth (Non-Member)**

**Respondent: Emily Burdon** 

#### Discipline Committee's Findings:

Found for Complainant, Emily Burdon and directed that Sarah Muth be debarred for a period of five (5) years. The Discipline Committee levied costs associated with the investigation and hearing in the amount of \$172.50 (including HST) against Sarah Muth.

Found for Complainant, Emily Burdon and directed that Sarah Muth's CKC membership be terminated for a period of five (5) years. The Discipline Committee levied costs associated with the investigation and hearing in the amount of \$287.50 (including HST) against Sarah Muth.

#### Appeal Committee's Findings:

Upheld the appeal in part and varied the penalty from a debarment of five (5) years to 90 days. The Appeal Committee varied the costs associated with the investigation and hearing against Sarah Muth in the amount of \$172.50 (including HST) to \$339.00 (including HST). Therefore, Sarah Muth is debarred for a period of 90 days commencing September 30, 2025. Furthermore, the administrative costs are due forthwith. Upheld the appeal in whole and the decision terminating Sarah Muth's CKC membership be set aside.

#### Appellant: Stéphanie Trudeau (CKC Member) **Respondent: CKC**

Discipline Committee's Findings:

Stéphanie Trudeau's CKC membership be terminated for a period of one (1) year. Furthermore, the Discipline Committee levied costs associated with the investigation and hearing in the amount of \$157.50 (including GST) against Mrs. Trudeau.

Stéphanie Trudeau be reprimanded. Furthermore, the Discipline Committee levied costs associated with the investigation and hearing in the amount of \$157.50 (including GST) against Mrs. Trudeau.

Stéphanie Trudeau be suspended of the privileges of the Club for a period of 90 days. Furthermore, the Discipline Committee levied costs associated with the investigation and hearing in the amount of \$157.50 (including GST) against Mrs. Trudeau.

#### Appeal Committee's Findings:

Dismissed the appeal and directed that the decision of the Discipline Committee be upheld. Therefore, Stéphanie Trudeau's CKC membership be terminated for a period of one (1) year, Mrs. Trudeau be reprimanded and she is suspended of the privileges of the Club for a period of 90 days. Furthermore, administrative costs are due forthwith.
